## A RESOLUTION AUTHORIZING THE AMENDMENT OF THE BOUNDARIES OF THE VILLAGES OF GLEN CREEK COMMUNITY DEVELOPMENT DISTRICT AND AUTHORIZING THE SUBMITTAL OF A PETITION TO AMEND THE BOUNDARIES OF THE DISTRICT TO THE CITY COUNCIL OF THE CITY OF BRADENTON, FLORIDA, UNDER SECTION 190.046, FLORIDA STATUTES.

WHEREAS, the Villages of Glen Creek Community Development District (the "District") is a local unit of special-purpose government organized and existing in accordance with the Uniform Community Development District Act of 1980, as amended, Chapter 190, Florida Statutes; and

WHEREAS, the Board of Supervisors of the District (the "Board") desires to amend the boundaries of the District and to submit a petition to amend the boundaries of the Villages of Glen Creek Community Development District (the "Petition") for the area described in Exhibit "A" attached hereto.

## NOW THEREFORE, BE IT RESOLVED that:

1. The Board hereby authorizes and approves the amendment of the District boundaries, and the Board hereby authorizes and directs the Chair to sign and submit the Petition to the City Council of the City of Bradenton, Florida.

2. The Board hereby authorizes and directs the Chair, the Vice Chair, any other member of the Board, the District Counsel, and the District Manager to take any action or to offer testimony in any proceeding held in connection with obtaining approval of the Petition from the City Council of the City of Bradenton, Florida.

3. This Resolution shall take effect immediately upon its adoption.
